For B2B wholesale orders, we provide complete third-party physical order fulfillment of products under electronic data interchange (EDI) protocols.

We also offer customer service, account billing, and other third-party logistics (3PL) support services for business-to-business (B2B) and business-to-consumer (B2C) clients.

As a fulfillment house, we deliver the back-end services that our clients need to service their customers, while we operate as our clients' invisible outsourced backroom.
