Coast to Coast Fulfillment is a full-service third-party product fulfillment house (3PF) and third-party logistics (3PL) service specializing in supporting marketers that sell their merchandise through *all* distribution channels *simultaneously*. Our *omni-channel* facility is strategically located in the heart of the Northeast Corridor, within one-day via ground shipping of over 60 million people. We process orders on behalf of our clients and then ship the orders to their wholesale or retail customers. This is our specialty, so we do it faster and at less expense than our clients can do it themselves.

We receive orders, process payments, pick, pack, and ship products, provide merchant account and data management services for business-to-consumer (B2C) sales, and for business-to-business (B2B) orders to retail stores and their distribution centers (DCs). For B2B wholesale orders, we also provide complete third-party physical order fulfillment of products under electronic data interchange (EDI) protocols.

We also offer customer service, account billing, and other third-party logistics (3PL) support services for business-to-business (B2B) and business-to-consumer (B2C) clients. Our online portal provides live pertinent data 24/7.

As a fulfillment house, we deliver the back-end services that our clients need to service their customers, while we operate as our clients' invisible outsourced backroom.

We provide complete product fulfillment services for merchandise ranging from consumer electronics, health and beauty products, nutraceuticals and over-the-counter medical products, to fashion jewelry, apparel, promotional items, toys, games, and marketing and sales literature.
